## 3 SEC. 4. STATEMENT OF POLICY.

4 It is the policy of the United States—

5 (1) to strongly condemn the ongoing violence
6 and widespread human rights violations perpetrated
7 against the Syrian people by the regime of President
8 Bashar al-Assad;

9 (2) to support civilians and innocent victims of
10 the conflict in Syria, particularly women and chil11 dren who are displaced and vulnerable, to physical
12 and psychological exploitation;

1 (3) to assist the people of Syria in meeting 2 basic needs, including access to food, health care, 3 shelter, and clean drinking water; 4 (4) to affirm the neutrality of medical profes-5 sionals providing humanitarian assistance and health 6 care on a non-political basis and to condemn attacks 7 against such personnel or interference in the provi-8 sion of medical care; 9 (5) to support efforts of democratically oriented 10 political opposition groups in Syria to agree upon a 11 political transition plan that is inclusive and protects 12 the rights of all minority ethnic groups in the coun-13 try; 14 (6) to work with the international community, 15 including multilateral organizations and host coun-16 tries, to support Syrian refugees in Lebanon, Tur-17 key, Jordan, Egypt, Iraq, and other host countries; 18 (7) to welcome the pledges of humanitarian as-19 sistance made by the Governments of Australia, Bot-20 swana, Brazil, Canada, China, India, Japan, Repub-21 lic of Korea, Kuwait, Morocco, New Zealand, Qatar, Saudi Arabia, Turkey, the United Arab Emirates, 22 23 and members of the European Union, and to encour-24 age prompt delivery of those pledges which will con-25 tribute to meeting the needs of the victims of this 3

1	conflict, and to encourage all donors to coordinate
2	with the United Nations;
3	(8) to support efforts to identify, recover, and
4	dispose of chemical weapons and other conventional
5	and unconventional weapons stockpiled in Syria;
6	(9) to recognize the National Coalition for Syr-
7	ian Revolutionary and Opposition Forces (SOC) as
8	the sole and legitimate representative of the people
9	of Syria;
10	(10) to support the efforts of the National Coa-
11	lition for Syrian Revolutionary and Opposition
12	Forces (SOC) to establish a transitional government;
13	(11) to support transparent and impartial judi-
14	cial processes, in which Syrians have a leading voice,
15	for all those who have committed gross violations of
16	human rights and international law, while noting
17	that the majority of these violations have been com-
18	mitted by the Assad regime;
19	(12) to help ensure that, once a stable transi-
20	tional government is established in Syria, it is com-
21	mitted to multiparty democracy, open and trans-
22	parent governance, respect for human rights and re-
23	ligious freedom, protection of refugees and asylees,
24	promoting peace and stability with its neighbors, en-

hancing the rule of law, and rehabilitating and re integrating former combatants;

3 (13) to affirm that the end of the Assad regime
4 is in the national security interests of the United
5 States, as it would weaken the position of Iran and
6 Hezbollah in the region and allow for the return of
7 displaced persons currently seeking refuge in host
8 countries; and

9 (14) to fully implement existing sanctions on 10 Syria, including Executive Order 13606, dated April 11 22, 2012, which sanctions any individual or entity 12 that assists or enables the commission of serious 13 human rights abuses, through computer or network 14 disruption, tracking, or monitoring, by the Govern-15 ment of Syria or the Government of Iran.
