## A BILL

To require the Secretary of State to establish a quantum cooperation program to enhance international cooperation in quantum information science.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “International Quantum  
5       Research Exchange Act”.

6 **SEC. 2. DEFINITIONS.**

7       In this Act:

8           (1) APPROPRIATE CONGRESSIONAL COMMIT-  
9       TEES.—The term “appropriate congressional com-  
10       mittees” means the following:

(B) The Committee on Foreign Affairs of  
the House of Representatives.

(C) The Committee on Commerce, Science,  
and Transportation of the Senate.

(D) The Committee on Energy and Commerce of the House of Representatives.

18 SEC. 3. DEPARTMENT OF STATE INTERNATIONAL QUAN-  
19 TUM COOPERATION PROGRAM.

20 (a) IN GENERAL.—The Secretary of State shall es-  
21 tablish and carry out a program—

1       (or consortia thereof) engaged in international col-  
2       laborative research; and

3               (2) to support international scientist exchange  
4       programs, including exchange programs that vary in  
5       length from multi-day to multi-year visits.

6       (b) PROGRAM ALIGNMENT.—

7               (1) COORDINATION.—In carrying out the pro-  
8       gram under subsection (a), the Secretary of State  
9       shall coordinate with—

10               (A) the Director of the Office of Science  
11       and Technology Policy;

12               (B) the Director of the National Quantum  
13       Coordination Office (established under section  
14       102(a) of the National Quantum Initiative Act  
15       (15 U.S.C. 8812(a)));

16               (C) the Co-Chairs of the Subcommittee on  
17       Quantum Information Science of the National  
18       Science and Technology Council (established  
19       under section 103(a) of the National Quantum  
20       Initiative Act (15 U.S.C. 8813(a)); and

21               (D) the Co-Chairs of the Subcommittee on  
22       the Economic and Security Implications of  
23       Quantum Information Science of the National  
24       Science and Technology Council (established

1           under section 105(a) of the National Quantum  
2           Initiative Act (15 U.S.C. 8814a(a)).

3           (2) STRATEGIC ALIGNMENT.—In carrying out  
4           the program under subsection (a), the Secretary of  
5           State shall—

6                 (A) ensure alignment with the National  
7                 Quantum Information Science Strategy; and

8                 (B) only fund collaborative research pro-  
9                 grams with countries who have signed quantum  
10                 cooperation statements with the United States.

11           (3) RESEARCH SECURITY.—The activities au-  
12           thorized under this section shall be carried out in a  
13           manner consistent with the following:

14                 (A) Subtitle D of title VI of the Research  
15                 and Development, Competition, and Innovation  
16                 Act (division B of Public Law 117–167; 42  
17                 U.S.C. 19231 et seq.).

18                 (B) National Security Presidential Memo-  
19                 randum–33 (relating to supported research and  
20                 development national policy), issued January  
21                 2021, and its implementation guidance on re-  
22                 search security and research integrity, issued  
23                 January 2022, or any successor policy docu-  
24                 ment or guidance related to strengthening pro-  
25                 tections on research and development, funded

1           by the Federal Government, against the influence  
2           and exploitation of foreign governments.

3        (c) CONSULTATION.—In developing and operating  
4   the program required under subsection (a), the Secretary  
5   of State shall consult with—

6           (1) the appropriate congressional committees;  
7           (2) the Special Envoy for Critical and Emerg-

8           ing Technologies;

9           (3) United States industry leaders;

10          (4) any technology experts the Secretary con-  
11          siders relevant, including experts from academia;  
12          and

13          (5) representatives from any United States  
14          Government agency the Secretary considers relevant.

15        (d) ANNUAL REPORT.—Not later than 2 years after  
16   the date of the enactment of this Act, and annually there-  
17   after, the Secretary shall submit to the appropriate con-  
18   gressional committees a report that contains the following  
19   elements:

20           (1) A description of the activities pursued under  
21          the authorities of this section during the prior year.

22           (2) A list of priority countries with which the  
23          Department of State seeks to pursue increased col-  
24          laboration on quantum information science.

1       (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
2 authorized to be appropriated to carry out the program  
3 required by subsection (a) \$20,000,000 for fiscal year  
4 2026.

5       (f) SUNSET.—The authorities under this section shall  
6 terminate on the date that is 10 years after the date of  
7 the enactment of this title.
