As I think most of my colleagues know, I disagree with Mike Waltz on some issues

including his use of the unclassified systems to coordinate sensitive discussions.

But I do intend to vote for Mr. Waltz today. I think he represents a moderating force

within the Administration. He has a distinguished record of military service, and he has

an extensive background in national security policymaking.

Mr. Waltz did not represent himself to me as someone who wants to retreat from the

world, and I think that is particularly important at this time.

That said, I do intend to hold him accountable through the Senate Foreign

Relations Committee's oversight role in the months and years ahead and make sure that

he lives up to the impression and the statements that he has made to this committee.

I am also pleased to know that the Administration has decided that it is going to

distribute \$75 million in lifesaving assistance.

The aid will go to two important organizations who have longstanding bipartisan

support, the World Food Programme and the International Organization for Migration, and

I believe that saving lives through American assistance globally is not only the right thing

to do, but it advances our national security and economic interests around the world.

So, again, looking at the China report that we produced last week, I think the

United States should continue using its tools of soft power to influence foreign partners

and create a safer, more stable world that our citizens benefit from.

So thank you, Mr. Chairman.

The Chairman: Thank you, Senator Shaheen.

Thank you for your thoughtful consideration of this, even though it took a little

longer than you -- thank you so much for considering it. We appreciate that.
