The committee met, pursuant to notice, at 9:42 a.m., in S-116, The Capitol, Hon.

James E. Risch, chairman of the committee, presiding.

The Chairman: The Foreign Relations Committee of the United States Senate will come to order. Today we have a business meeting to consider a number, six to be exact, of appointments to send to the floor. Before we do that, the distinguished ranking member wishes to make a statement.

Senator Shaheen: Well, thank you, Mr. Chairman, and I appreciate our being able to get these nominees voted on today.

But I had two meetings yesterday, one with a delegation from Moldova that included their Foreign Minister and their Speaker of Parliament. The other was with the Serbian Foreign Minister. And when I asked each of them, "What can we do, in Congress, to be helpful to you, as you're thinking about the challenges you have in your country, especially against Russia?" what both of them said was, "Give us an ambassador." We need to urge the State Department to move career Ambassadors. We have a whole list of them, and so far I think we have moved five or six in this committee. And it's unacceptable that we are here, year-end to this Administration, and we still have so many critical places that we do not have ambassadors.

So I do not know, Mr. Chairman, if we can send a message to Secretary Rubio from the committee, urging them to move career ambassadors, if we can send a message to the White House. But I think it is really critical that we do this. It is in America's interest to have our ambassadors around the world.

The Chairman: Thank you, Senator. I first would like to concur with you that we need people in these places, particularly places like Moldova and Serbia. And your thoughts in that regard are not unique to yourself. I have had a number of discussions with the people at the State Department, including at the very top. They are busy over there, and I know that is not an acceptable excuse, but it is a fact of life. And they are truly trying to get through these.

As you know, they do a thorough job of vetting and of preparing. It should not be as much of a problem when they have a career person to put in there, particularly when they have had a long career. But I will redouble my efforts in that regard, I promise. And I agree with you 100 percent, particularly in a country like Moldova. I mean, these people are struggling to keep the bear from eating them. They really need our people there to help them.

So your points are well taken, and I will do what I can.

Senator Shaheen: Thank you.

The Chairman: Thank you so much. So with that, do you want to do these one at a time?

On behalf of the Kentucky Jewish Council, I am writing to express our strong and unequivocal support for the appointment of Rabbi Yehuda Kaploun as the United States Special Envoy to Monitor and Combat Antisemitism.
