8	manner that reflects his belief that domestic politics ends at the water's edge, and
9	that the United States speaks with one voice on matters of foreign relations.
10	Whereas he has fought to reassert Congress's authority, Article I authority,
11	especially in the realm of foreign relations, by introducing bipartisan legislation
12	to update the 2001 authorization for the use of force.
13	Whereas his previous experience, and living in South Africa, Zimbabwe,
14	Namibia, has informed his leadership of the African Affairs subcommittee.
15	Whereas as chairman of the subcommittee, he has worked on legislation to
16	reauthorize the Africa Growth and Opportunity Act to bring electricity to parts
17	of Africa that lack it, and to allow the Millennium Challenge Corporation to enter
18	into current compacts with African countries.

1	Whereas he has worked in a bipartisan fashion to pass into law the
2	Eliminate, Neutralize, and Disrupt Wildlife Trafficking Act of 2016, a bill that
3	enhanced tools available to the federal government to fight wildlife trafficking
4	and poaching around the world.
5	Whereas he introduced and pushed through the passage of the Zimbabwe
6	Democracy and Economic Recovery Amendment Act of 2018, to update U.S.
7	policy towards Zimbabwe, which was signed into law on August the 8th, 2018.
8	Whereas he has been an advocate for regular budgetary order and
9	responsible steward of taxpayer dollars.
10	Whereas he will retire from the Senate at the conclusion of the 115th
11	Congress on January 3rd, 2019.
12	Now, therefore, be it resolved that the Committee on Foreign Relations
13	expresses to Jeff Flake its admiration, appreciation, and high regard, and further
14	be resolved as the committee extends to Senator Flake its most sincere best
15	wishes for the future, our friend, Jeff Flake."

1	SENATOR MENENDEZ. Yes, Mr. Chairman, just briefly.
2	First, I hope that as we are dealing with the Yemen resolution on the floor,
3	that I look forward to working with Chairman Risch on hopefully a bipartisan
4	piece of legislation that creates real accountability for Saudi Arabia, and then the
5	Yemen situation, and I am certainly going to be pursuing that vigorously in the
б	next Congress with colleagues on both sides of the aisle. At times
7	THE CHAIRMAN. Yeah.
8	SENATOR MENENDEZ. to be able to do something.
9	But I just want to speak to two of the nominees for a moment. Armenia
10	and the Caucasus region continue to be vital to regional and global security.
11	According to the OSCE, Armenia's elections over the weekend met international
12	standards, and we look forward to supporting the government's efforts to build
13	strong democratic institutions and a vibrant Armenian economy, and oppose any
14	efforts to violate Armenia's sovereignty.
15	Now the one thing I am going to vote for this nominee, but throughout
16	my time in the Senate I have advocated for an honest accounting of the Armenian
17	genocide. I believe we have a moral imperative to recognize the atrocities that
18	were committed against the Armenian people.

1	Ms. Tracy's experience in Russia and Central Asia positions her to help
2	navigate U.S. policy in this critical time. I am going to support her nomination,
3	but expect to work closely with her on how she will encourage an honest
4	acknowledgment of the Armenian genocide, support Armenia's ongoing efforts
5	to ensure accountable, citizen-responsive governance, and support efforts to
6	reach a peaceful settlement of the Nagorno-Karabakh conflict.
7	Lastly, I support Mr. Litzenberger's nomination. We expect to have close
8	and continuing dialogue with him on how he will urge the Azeris to step back
9	from any threatening behavior that could disrupt the line of contact in Nagorno-
10	Karabakh, support respect for human rights, and support efforts to reach a
11	peaceful settlement in the Nagorno-Karabakh conflict.
12	Thank you, Mr. Chairman.

5	First of all, I want to thank all my colleagues for their strong support for
6	the resolution on the Kerch Strait. I was in Ukraine last weekend, spent more
7	than two hours with President Poroshenko. I cannot tell you how much he
8	appreciated that strong support, so I want to thank you for that.
9	But I also did want to gauge your interest on another resolution. I think
10	Putin's strategy here is very clear. He is going to try to weaken those ports, port
11	cities, starve them off. He's clearly violating his agreement with Ukraine, as it
12	relates to freedom for navigation of the Kerch Strait.
13	So I was pleased that the European Parliament apparently today has
14	passed a resolution to stop the Nord Stream 2. So I would like to propose and
15	work with committee members on a resolution calling for the halt to construction
16	on the Nord Stream and call for a very strong freedom of navigation operation at
17	the Kerch Strait to ensure navigation.

1	I think it is critical. I am concerned that we are not going to have that kind
2	of strong response, and if we do not, it will be perceived as weakness, and Putin
3	will just continue on with his next steps.
4	So, you know, we do not have to discuss it here, but on the floor during
5	our votes I would love to talk to members in terms of exactly how we can do
б	that, and what level support there would be for that kind of resolution.
7	THE CHAIRMAN. Thank you.
8	SENATOR PORTMAN. Mr. Chair.
9	THE CHAIRMAN. Thank you for your leadership on that issue.
10	Yes, sir?
11	SENATOR PORTMAN. I think Senator Johnson raises a really good point. I
12	did have an opportunity to meet with the ambassador, and also the vice-admiral
13	from the Ukrainian Navy yesterday. And this commander walked through what
14	has happened with regards to the ships and the sailors, clearly in violation of
15	everything, international law, certainly the agreement with Ukraine.
16	I am concerned we have not stepped up strongly enough, not just the
17	United States, but as a global
