## A BILL

To repeal the prohibition on the transfer of articles on the United States Munitions List to the Republic of Cyprus.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "End the Cyprus Arms
- 5 Embargo Λct".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:
- 8 (1) The Republic of Cyprus is a vital strategic
- 9 partner to the United States.

SENSE OF THE SENATE. 18 It is the sense of the Senate that— 19 (1) the direct sale or transfer of arms by the 20 United States to the Republic of Cyprus would ad-21 vance United States' security interests in Europe by 22 helping to reduce the dependence of Cyprus on other 23 countries for defense-related materiel, including 24 countries that pose challenges to United States in-

terests around the world; and
