1 At the end of title III, add the following:

2 SEC. 304. MODIFICATIONS TO AND REAUTHORIZATION OF
3 SANCTIONS WITH RESPECT TO HUMAN
4 RIGHTS VIOLATIONS.

5 (a) DEFINITIONS.—Section 1262 of the Global
6 Magnitsky Human Rights Accountability Act (Subtitle F
7 of title XII of Public Law 114–328; 22 U.S.C. 2656 note)
8 is amended by striking paragraph (2) and inserting the
9 following:

10 "(2) IMMEDIATE FAMILY MEMBER.—The term
11 "immediate family member', with respect to a foreign

person, means the spouse, parent, sibling, or adult
 child of the person.".

3 (b) SENSE OF CONGRESS.—The Global Magnitsky
4 Human Rights Accountability Act (Subtitle F of title XII
5 of Public Law 114–328; 22 U.S.C. 2656 note) is amended
6 by inserting after section 1262 the following new section:
7 "SEC. 1262A. SENSE OF CONGRESS.

8 "It is the sense of Congress that the President should 9 establish and regularize information sharing and sanc-10 tions-related decision making with like-minded govern-11 ments possessing human rights and anti-corruption sanc-12 tions programs similar in nature to those authorized under 13 this subtitle.".

14 (c) IMPOSITION OF SANCTIONS.—

(1) IN GENERAL.—Subsection (a) of section
1263 of the Global Magnitsky Human Rights Accountability Act (Subtitle F of title XII of Public
Law 114–328; 22 U.S.C. 2656 note) is amended to
read as follows:

20 "(a) IN GENERAL.—The President may impose the
21 sanctions described in subsection (b) with respect to—

22 "(1) any foreign person that the President de-23 termines, based on credible information—

24 "(A) is responsible for or complicit in, or
25 has directly or indirectly engaged in, serious

1	human rights abuse or any violation of inter-
2	nationally recognized human rights;
3	"(B) is a current or former government of-
4	ficial, or a person acting for or on behalf of
5	such an official, who is responsible for or
6	complicit in, or has directly or indirectly en-
7	gaged in—
8	"(i) corruption, including—
9	"(I) the misappropriation of state
10	assets;
11	"(II) the expropriation of private
12	assets for personal gain;
13	"(III) corruption related to gov-
14	ernment contracts or the extraction of
15	natural resources; or
16	"(IV) bribery; or
17	"(ii) the transfer or facilitation of the
18	transfer of the proceeds of corruption;
19	"(C) is or has been a leader or official of—
20	"(i) an entity, including a government
21	entity, that has engaged in, or whose mem-
22	bers have engaged in, any of the activities
23	described in subparagraph (A) or (B) dur-
24	ing the tenure of the leader or official; or

"(ii) an entity whose property and in-
terests in property are blocked pursuant to
this section as a result of activities during
the tenure of the leader or official;
"(D) has materially assisted, sponsored, or
provided financial, material, or technological
support for, or goods or services to or in sup-
port of—
"(i) an activity described in subpara-
graph (A) or (B) that is conducted by a
foreign person;
"(ii) a person whose property and in-
terests in property are blocked pursuant to
this section; or
"(iii) an entity, including a govern-
ment entity, that has engaged in, or whose
members have engaged in, an activity de-
scribed in subparagraph (A) or (B) con-
ducted by a foreign person; or
"(E) is owned or controlled by, or acts or
is purported to act for or on behalf of, directly
or indirectly, a person whose property and in-
terests in property are blocked pursuant to this
section; and

1	"(2) any immediate family member of a person
2	described in paragraph (1).".
3	(2) SANCTIONS DESCRIBED.—Clause (ii) of sub-
4	section $(b)(2)(C)$ of such section is amended to read
5	as follows:
6	"(ii) GOOD.—In this subparagraph,
7	the term 'good' means any article, natural
8	or manmade substance, material, supply,
9	or manufactured product, including inspec-
10	tion and test equipment, and excluding
11	technical data.".
12	(3) Consideration of certain informa-
13	TION.—Subsection (c)(2) of such section is amended
14	by inserting "corruption and" after "monitor".
15	(4) Requests by congress.—Subsection (d)
16	of such section is amended—
17	(A) in paragraph (1)—
18	(i) in the matter preceding subpara-
19	graph (A), by striking "subsection (a)"
20	and inserting "subsection $(a)(1)$ "; and
21	(ii) in subparagraph (B)(i), by insert-
22	ing "or an immediate family member of
23	the person"; and
24	(B) in paragraph (2)—
25	(i) in subparagraph (A)—

1	(I) in the subparagraph heading,
2	by striking "HUMAN RIGHTS VIOLA-
3	TIONS" and inserting "SERIOUS
4	HUMAN RIGHTS ABUSE OR VIOLA-
5	TIONS OF INTERNATIONALLY RECOG-
6	NIZED HUMAN RIGHTS"; and
7	(II) by striking "described in
8	paragraph $(1)$ or $(2)$ of subsection
9	(a)" and inserting "described in sub-
10	section (a)(1) relating to serious
11	human rights abuse or any violation
12	of internationally recognized human
13	rights"; and
14	(ii) in subparagraph (B), in the mat-
15	ter preceding clause (i), by striking "de-
16	scribed in paragraph (3) or (4) of sub-
17	section (a)" and inserting "described in
18	subsection $(a)(1)$ relating to corruption or
19	the transfer or facilitation of the transfer
20	of the proceeds of corruption".
21	(5) TERMINATION OF SANCTIONS.—Subsection
22	(g) of such section is amended, in the matter pre-
23	ceding paragraph (1), by inserting "and the imme-
24	diate family members of that person" after "a per-
25	son''.

1	(d) REPORTS TO CONGRESS.—Section 1264(a) of the
2	Global Magnitsky Human Rights Accountability Act (Sub-
3	title F of title XII of Public Law 114–328; 22 U.S.C.
4	2656 note) is amended—
5	(1) in paragraph (5), by striking "; and" and
6	inserting a semicolon;
7	(2) in paragraph (6), by striking the period at
8	the end and inserting "; and"; and
9	(3) by adding at the end the following:
10	$\ensuremath{^{\prime\prime}}(7)$ A description of additional steps taken by
11	the President through diplomacy and assistance to
12	foreign or security sectors to address persistent un-
13	derlying causes of serious human rights abuse, viola-
14	tions of internationally recognized human rights,
15	and corruption in each country in which foreign per-
16	sons with respect to which sanctions have been im-
17	posed under section 1263 are located.".
18	(e) REPEAL OF SUNSET.—Section 1265 of the Global
19	Magnitsky Human Rights Accountability Act (Subtitle F
20	of title XII of Public Law 114–328; 22 U.S.C. 2656 note)
21	is repealed.
