A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Consular and Adminis-
- 5 trative Support Act of 2020".

1	SEC. 2. CONSULAR AFFAIRS AND REPATRIATION RE-
2	SOURCES OF THE DEPARTMENT OF STATE.
3	Section 1 of the State Department Basic Authorities
4	Act of 1956 (22 U.S.C. 2651a) is amended by adding at
5	the end the following:
6	"(h) Responding to Epidemics or Pandemics.—
7	"(1) STATEMENT OF POLICY.—It shall be the
8	policy of the United States, during any public health
9	emergency caused by an epidemic or pandemic—
10	"(A) to not leave any United States na-
11	tional involuntarily stranded in a foreign coun-
12	try; and
13	"(B) to provide all appropriate and avail-
14	able assistance to United States nationals to fa-
15	cilitate their return to the United States, when
16	requested, for the duration of the public health
17	emergency.
18	"(2) Definitions.—In this subsection—
19	"(A) the term 'tier two response' means a
20	single, comprehensive approach to incident
21	management for the National Passport Center
22	and the National Visa Center during a national
23	emergency caused by an epidemic or pandemic,
24	including—
25	"(i) the promulgation of protocols for
26	communication, information and planning,

1	emergency assistance, logistics manage-
2	ment and support, staffing, and financial
3	management; and
4	"(ii) the identification of roles and re-
5	sponsibilities for response and staffing,
6	critical infrastructure, and international
7	and interagency coordination; and
8	"(B) the term 'United States national'
9	means an individual who is—
10	"(i) a United States citizen; or
11	"(ii) an alien lawfully admitted for
12	permanent residence to the United States.
13	"(3) Establishment of repatriation task
14	FORCE.—In responding to an infectious disease out-
15	break that is sustained, severe, and spreading, in-
16	cluding a determination by the Director-General of
17	the World Health Organization of a public health
18	emergency of international concern under Article 12
19	of the International Health Regulations, done at Ge-
20	neva May 23, 2005, the Secretary shall establish,
21	under the direction of the Assistant Secretary for
22	Consular Affairs, a Repatriation Task Force, which
23	shall—
24	"(A) formulate and implement policies that
25	protect and advance United States interests in

1	protecting and safeguarding the needs of
2	United States nationals, including repatriation
3	and other health and medical needs;
4	"(B) manage, in coordination with relevant
5	diplomatic posts, all communication and coordi-
6	nation with United States nationals regarding
7	their needs, including repatriation and health
8	and medical matters;
9	"(C) ensure that procedures implemented
10	by American Citizen Services are integrated
11	into, and reflected in, the decision-making proc-
12	ess within the Department of State;
13	"(D) coordinate the functions of American
14	Citizen Services, including repatriation, re-
15	sponding to health and medical needs, and
16	other relevant functions, within the Department
17	of State;
18	"(E) incorporate the functions of American
19	Citizen Services, including repatriation and
20	other health and medical needs priorities, into
21	the activities of the Department of State;
22	"(F) coordinate efforts of the Department
23	of State with relevant Federal departments and
24	agencies to meet the needs of American Citizen

1	Services, including repatriation and other
2	health and medical needs; and
3	"(G) support American Citizen Services
4	with repatriation and other health and medical
5	needs, including coordinating and providing re-
6	sources to meet all repatriation needs.
7	"(4) Personnel.—The Secretary shall ensure
8	that there are sufficient personnel serving in the Of-
9	fice of American Citizen Services and Crisis Manage-
10	ment and the Bureau of Consular Affairs or other
11	Department of State personnel in the countries af-
12	fected by the epidemic or pandemic, to carry out the
13	responsibilities set forth in paragraph (3), including
14	repatriation matters.
15	"(5) National passport center and na-
16	TIONAL VISA CENTER.—In responding to an infec-
17	tious disease outbreak described in paragraph (3),
18	the Secretary should activate a tier two response by
19	the National Passport Information Center and the
20	National Visa Center.
21	"(6) Notification requirement.—Not later
22	than 15 days before the Department of State in-
23	tends to discontinue the repatriation services de-
24	scribed in paragraph (3) in any region, country, or
25	part thereof during a public health emergency

1	caused by an epidemic or pandemic affecting such
2	region, country, or part, the Secretary shall notify,
3	by all appropriate means, all United States nationals
4	affected by this service interruption, the Committee
5	on Foreign Relations of the Senate, and the Com-
6	mittee on Foreign Affairs of the House of Rep-
7	resentatives of the date after which the Department
8	of State will no longer provide such services to
9	United States nationals seeking repatriation to the
10	United States.".

6	CERTAIN SPECIAL IMMIGRANT VISAS.
7	(a) COVERED VISA DEFINED.—In this section, the
8	term "covered visa" means a special immigrant visa
9	that—
10	(1) is authorized under—
11	(A) section 1059 of the National Defense
12	Authorization Act for Fiscal Year 2006 (Public
13	Law 109–163; 8 U.S.C. 1101 note);
14	(B) section 1244 of the Refugee Crisis in

17	(C) section 602 of the Afghan Allies Pro-

24	(1) In general.—Given the current travel re-

4 for refugee resettlement to the United States, the

5 Secretary of State, in cooperation with the Secretary

7 lidity of a covered visa until a date that is not ear-

8 lier than 6 months after such extension date.

- 9 (2) NO EFFECT ON NUMERICAL LIMITATION.—
 10 Any extension under paragraph (1) may not be
 11 counted against any numerical limitation on the
 12 number of visas available under any law referred to
 13 in subsection (a)(1).
- 14 (c) EXTENSION OF APPLICATION PERIOD.—If the 15 application period for any covered visa is scheduled to expire between February 1, 2020, and 60 days after the date 16 17 on which the International Organization for Migration re-18 sumes flights for refugee resettlement to the United 19 States, the Secretary of State shall extend such applica-20 tion period so that eligible applicants may apply for a cov-21 ered visa until the date that is 6 months after such flight
- 22 resumption date.
