6 (2) condemns Vladimir Putin and his regime
7 for targeting political opponents and working to
8 cover up the assassination of Boris Nemtsov;

9 (3) urges the United States Government, in all
10 its interactions with the Government of the Russian
11 Federation, to raise the case of the assassination of
12 Boris Nemtsov and underscore the necessity of
13 bringing the organizers and masterminds to justice;

(4) supports the efforts by the Organization for
 Security and Cooperation in Europe and its Par liamentary Assembly to initiate oversight of the offi cial Russian investigation into the assassination of
 Boris Nemtsov;

6 (5) calls on the Government of the Russian 7 Federation to allow an impartial international inves-8 tigation of the assassination of Boris Nemtsov and 9 to cooperate with the Parliamentary Assembly of the 10 Organization for Security and Cooperation in Eu-11 rope and the Parliamentary Assembly of the Council 12 of Europe in their ongoing inquiries over this case;

13 (6) calls on the Secretary of State and the Sec-14 retary of the Treasury to use their authority under 15 the Sergei Magnitsky Rule of Law Accountability 16 Act of 2012 (title IV of Public Law 112–208; 22) 17 U.S.C. 5811 note) and the Global Magnitsky 18 Human Rights Accountability Act (subtitle F of title 19 XII of Public Law 114–328) to designate individuals 20 whom they determine to have been involved in the 21 assassination of Boris Nemtsov as perpetrators, or-22 ganizers, or masterminds, on the list of specially 23 designated nationals and blocked persons maintained 24 by the Office of Foreign Assets Control of the De-25 partment of the Treasury, freezing their assets and DAV19758

making them ineligible to receive United States
 visas;

3 (7) calls on the Secretary of State, in consulta-4 tion with the Director of National Intelligence, to 5 prepare and submit to Congress a report detailing 6 the circumstances of the February 27, 2015, assas-7 sination of Boris Nemtsov, including the list of indi-8 viduals whom they determine to have been involved 9 in the assassination as perpetrators, organizers, or 10 masterminds, and identifying what measures, if any, 11 have been taken by the Government of the Russian 12 Federation to investigate this crime and bring its 13 perpetrators, organizers, and masterminds to justice, 14 and evaluating the effectiveness of such measures; 15 and

16 (8) urges the Secretary of State to take all pos-17 sible steps to—

18 (A) investigate the business activities of
19 Ramzan Kadyrov and any entities controlled by
20 Ramzan Kadyrov outside the Russian Federa21 tion; and

(B) determine whether any such activities,
or any entities facilitating such activities, are in
violation of the sanctions imposed on Ramzan
Kadyrov pursuant to the authorities provided
