REPEAL OF AUTHORIZATION FOR USE OF MILITARY 1 FORCE AGAINST IRAQ RESOLUTION OF 2002. $\mathbf{2}$ The Authorization for Use of Military Force Against 3 Iraq Resolution of 2002 (Public Law 107-243; 116 Stat. 4 1498; 50 U.S.C. 1541 note) is hereby repealed. 5 SEC. 4. AUTHORIZATION FOR USE OF UNITED STATES 6 7 ARMED FORCES TO DEFEND UNITED STATES GOVERNMENT PERSONNEL AND FACILITIES 8 ġ. AND TO COUNTER TERRORIST THREATS IN 10IRAQ. (a) AUTHORIZATION.—The President is authorized to 11 use the Armed Forces of the United States as he deter-12 mines to be necessary and appropriate in order to— 13 (1) defend the national security of the United 14 States against the continuing threat posed by inter-15 national terrorist organizations and sponsors of 16 international terrorism operating in Iraq; and 17(2) prevent and respond to future attacks 18 against United States Government personnel and fa-19 cilities by international terrorist organizations and 2021sponsors of international terrorism operating in 22 Iraq. (b) PRESIDENTIAL DETERMINATION.—In connection 23with the exercise of the authority granted in subsection 24 (a) to use force the President shall, prior to such exercise 25 or as soon thereafter as may be feasible, but no later than 26

48 hours after exercising such authority, make available
 to the Speaker of the House of Representatives and the
 President pro tempore of the Senate his determination
 that—

5 (1) reliance by the United States on further
6 diplomatic or other peaceful means alone will not
7 adequately protect the national security of the
8 United States against the continuing threat posed by
9 international terrorist organizations and sponsors of
10 international terrorism operating in Iraq; and

11 (2) acting pursuant to this joint resolution is 12 consistent with the United States and other coun-13 tries continuing to take the necessary actions 14 against international terrorist and terrorist organi-15 zations.

16 (c) WAR POWERS RESOLUTION REQUIREMENTS:---

(1) SPECIFIC STATUTORY AUTHORIZATION.—
Consistent with section 8(a)(1) of the War Powers
Resolution, Congress declares that this section is intended to constitute specific statutory authorization
within the meaning of section 5(b) of the War Powers Resolution.

(2) APPLICABILITY OF OTHER REQUIREMENTS.—Nothing in this joint resolution supersedes
any requirement of the War Powers Resolution.

1 SEC. 5. REPORTS TO CONGRESS.

2 (a) REPORTS.—The President shall, at least once
3 every 60 days, submit to the Congress a report on matters
4 relevant to this joint resolution, including actions taken
5 pursuant to the exercise of authority granted in section
6 4 and the status of planning for efforts that are expected
7 to be required after such actions are completed.

(b) SINGLE CONSOLIDATED REPORT.—To the extent 8 that the submission of any report described in subsection 9 (a) coincides with the submission of any other report on 10 matters relevant to this joint resolution otherwise required 11to be submitted to Congress pursuant to the reporting re-12 quirements of the War Powers Resolution (Public Law 13 93–148), all such reports may be submitted as a single 14 15 consolidated report to Congress.
