5 (a) IN GENERAL.—

6 (1) EXPORT LICENSE APPLICATIONS.—

7 (A) SUBMISSION TO CONGRESS.—The Sec-
 8 retary shall submit to the specified congress-
 9 sional committees a detailed list of all export li-
 10 cense applications, including requests for mar-

1 keting licenses, for the sale of defense articles
2 and defense services to Ukraine.

3 (B) CONTENTS.—The list submitted under
4 subparagraph (A) shall include—

5 (i) the date on which the application
6 or request was first submitted;

7 (ii) the current status of each applica-
8 tion or request; and

9 (iii) the estimated timeline for adju-
10 dication of such applications or requests.

11 (C) PRIORITY.—The Secretary should give
12 priority to processing the applications and re-
13 quests included on the list submitted under sub-
14 paragraph (A).

15 (2) LETTERS OF REQUEST.—The Secretary
16 shall submit to the specified congressional commit-
17 tees a detailed list of all pending Letters of Request
18 for Foreign Military Sales to Ukraine, including—

19 (A) the date on which each such letter was
20 first submitted;

21 (B) the current status of each such letter;
22 and

23 (C) the estimated timeline for the adju-
24 dication of each such letter.

25 (b) REPORTS.—

1 (1) IN GENERAL.—Not later than 30 days after
2 the date of the enactment of this Act, and every 90
3 days thereafter until the date set forth in paragraph
4 (2), the Secretary shall submit a report to the speci-
5 fied congressional committees that describes the sta-
6 tus of the applications, requests for marketing li-
7 censes, and Letters of Request described in sub-
8 section (a).

9 (2) TERMINATION DATE.—The date set forth in
10 this paragraph is the earlier of—

11 (A) the date on which the President cer-
12 tifies to Congress that the sovereignty and ter-
13 ritorial integrity of the Government of Ukraine
14 has been restored; or

15 (B) the date that is 5 years after the date
16 of the enactment of this Act.

17 (c) SPECIFIED CONGRESSIONAL COMMITTEES DE-
18 FINED.—In this section, the term “specified congressional
19 committees” means—

20 (1) the Committee on Foreign Relations of the
21 Senate; and

22 (2) the Committee on Foreign Affairs of the
23 House of Representatives.
