

A 21ST CENTURY VISION OF U.S. GLOBAL LEADERSHIP BUILDING A BETTER, SAFER WORLD

The extraordinary global challenges and opportunities of the 21st century call for a new vision of America's engagement with the world. Today's U.S. investments in diplomacy and development are insufficient to promote global stability, expand the benefits of the global economy, and guarantee American security. Our increasingly interconnected world requires strong U.S. leadership to strengthen democratic governance, harness economic potential, alleviate global poverty and improve human conditions. American investments in these goals will reaffirm America's tradition of moral leadership, reduce our vulnerability to threats from destabilizing forces and improve America's image abroad. To achieve these objectives, the U.S. must use **smart power** – elevating diplomacy and development assistance while integrating them with our economic policies, defense and intelligence activities.

Keeping America Safe: Our Best Defense is a Good Offense

We cannot rely on military power alone to make our nation secure. This was a key conclusion of three recent reports on national security: the 9/11 Commission Report, the 2006 Department of Defense Quadrennial Review Report, and the 2006 National Security Strategy. America's prosperity and security have become inextricably linked to the prosperity and security of other nations and their people. Diplomatic initiatives, anti-proliferation programs, international exchanges and long-term investments in the health, education and livelihood of citizens of other nations keep America safer by combating terrorism, engendering goodwill toward the United States, and alleviating conditions that leave fragile countries such as Afghanistan, Iraq and Sudan vulnerable to the influence of extremist groups.

Revitalizing Our Moral Leadership

America's innovation and investment can address some of the world's greatest challenges. Ten million children die every year of preventable diseases before age five; 77 million children don't attend school; and more than one billion people lack clean water. Over the past four decades, U.S. assistance has helped millions of people feed their families; nearly eradicated river blindness and polio; helped Mozambique and El Salvador rebound from civil war; and put hundreds of thousands of HIV/AIDS patients on life-saving anti-retroviral treatments. Doing more to help governments of poor countries offer their people hope for a better future reaffirms our American humanitarian tradition and helps strengthen America's image abroad.

Promoting and Harnessing Economic Growth in Developing Countries

Over the past 40 years, trade has tripled as a share of our national economy. Since nearly 45% of U.S. exports go to developing countries, economic progress in those countries has a direct impact on our own. We must put in place development assistance and trade policies that will increase market access and create greater economic opportunities for both America and our trading partners.

A CALL TO ACTION FOR THE 2008 PRESIDENTIAL CANDIDATES

The next U.S. President must be prepared to tackle these challenging issues with bold new ideas that encourage global cooperation in the pursuit of freedom, security and opportunity. The next Administration needs to revitalize America's moral and pragmatic leadership by making greater investments in our diplomatic and development programs, modernizing our foreign assistance institutions, and improving the accountability and effectiveness of our foreign assistance programs.

We call on *all* of the 2008 Presidential candidates to elevate and strengthen our non-military tools of global engagement to build a better, safer, more prosperous America and world.

Admiral Charles S. Abbot, USN (Ret.)

Admiral Charles S. Abbot's last military assignment was Deputy Commander in Chief of the U.S. European Command in Stuttgart, Germany. Admiral Abbot also served as Commander of the U.S. Sixth Fleet and Commander, NAVAL Striking and Support Forces in Southern Europe.

General John P. Abizaid, USA (Ret.)

General John P. Abizaid served as the Commander of the U.S. Central Command from 2003 until his retirement in 2007. General Abizaid also served as the Executive Assistant to the Chairman of the Joint Chiefs of Staff, the Director of Strategic Plans and Policy on the Joint Staff and as the Director of the Joint Staff.

Admiral Stanley R. Arthur, USN (Ret.)

Admiral Stanley R. Arthur served as the Vice Chief of Naval Operations from 1992 – 1995. He also served as Commander, Naval Forces, Central Command during Operation Desert Storm. Admiral Arthur retired in 1995.

Admiral Frank L. Bowman, USN (Ret.)

Admiral Frank "Skip" L. Bowman is the former Chief of Naval Personnel. He also served as the Director of Naval Nuclear Propulsion. In this position, he simultaneously served as the Deputy Administrator for Naval Reactors in the National Nuclear Security Administration through the Department of Energy.

General Charles G. Boyd, USAF (Ret.)

General Charles G. Boyd served as the Deputy Commander in Chief, U.S. European Command from 1992 until his retirement in 1995. Before assuming his position at USEUCOM, he was Assistant Deputy Chief of Staff for plans and operations, USAF/HQ, Washington, D.C., and Commander of the Air University at Maxwell Air Force Base. From July 1998 to June 2001 he was Executive Director, U.S. Commission on National Security/21st Century (Hart-Rudman Commission).

Admiral Archie R. Clemins, USN (Ret.)

Admiral Archie R. Clemins served as the Commander in Chief of the U.S. Pacific Fleet from 1996 until his retirement in 1999. Previously, he was Commander, Pacific Fleet Training Command in San Diego, California and Commander, Seventh Fleet, headquartered in Yokosuka, Japan.

Lt. General John B. Conaway, USAF (Ret.)

Lt. General John B. Conaway served as the Chief of the National Guard Bureau from 1990 until his retirement in 1993. In 1981, he became Director of the Air National Guard. He was reappointed Director in April 1985 and then became Vice Chief in July 1988.

Lt. General John "Jack" Costello, USA (Ret.)

Lt. General John Costello was the Commanding General of the U.S. Army Space and Missile Defense Command/U.S. Army Space Command from 1998-2001 when he ended his 32-year career in the U.S. Army. Prior to that, he was the Commanding General of the U.S. Army Air Defense Artillery Center. He served at entry level, from platoon to major command and as an advisor in Vietnam.

Admiral Walter F. Doran, USN (Ret.)

Admiral Walter F. Doran commanded the United States Pacific Fleet from 2002 – 2005. Before commanding the Pacific Fleet, Admiral Doran served as Assistant to the Chairman of the Joint Chiefs of Staff as well as Commander of the U.S. Seventh Fleet, based in Japan. He also served as the Deputy Commander of the U.S. Southern Command.

General Ralph E. Eberhart, USAF (Ret.)

General Ralph E. Eberhart served as the Commander of the North American Aerospace Defense Command, as well as Commander, U.S. Northern Command from 2002 until his retirement in 2004. He previously served as the Commander in Chief of the U.S. Space Command, Commander of the Air Force Space Command, Commander Air Combat and as Vice Chief of Staff of the U.S. Air Force.

Admiral Leon A. Edney, USN (Ret.)

Admiral Leon A. Edney served as the Supreme Allied Commander in the Atlantic as well as the Commander in Chief of the U.S. Atlantic Command from 1990 – 1992. He previously served as the Vice Chief of Naval Operations from 1988 – 1990.

Admiral James O. Ellis, Jr., USN (Ret.)

Admiral James O. Ellis, Jr. completed a distinguished 39-year Navy career in 2004 as Commander of the United States Strategic Command. Previously, he served as Commander in Chief, U.S. Naval Forces, Europe and Commander in Chief, Allied Forces, Southern Europe during a time of historic NATO expansion and led United States and NATO forces in combat and humanitarian operations during the 1999 Kosovo crisis. Admiral Ellis is a graduate of the U.S. Naval Academy.

Admiral Thomas B. Fargo, USN (Ret.)

Admiral Thomas B. Fargo served as Commander of the United States Pacific Command from 2002 to 2005. He previously served as Director of Operations for the United States Atlantic Command during the Haiti intervention, Commander of the United States Fifth Fleet in Manama, Bahrain and Commander in Chief of the United States Pacific Fleet.

General John R. Galvin, USA (Ret.)

General John R. Galvin served as NATO's Supreme Allied Commander in Europe, as well as the Commander in Chief of the U.S. European Command from 1987 – 1992. He previously was the Commander in Chief of the U.S. Southern Command. Following his retirement from the Army, he served as Dean of the Fletcher School of Law and Diplomacy at Tufts University and as a member of the U.S. Commission on National Security/21st Century.

General Michael W. Hagee, USMC (Ret.)

General Michael W. Hagee was the 33rd Commandant of the United States Marine Corps where he served from 2003 – 2006. A graduate with distinction from the U.S. Naval Academy, Hagee held numerous command and staff assignments before retiring from the Marine Corps in January, 2007.

General Richard E. Hawley, USAF (Ret.)

General Richard E. Hawley served as the Commander of the Air Combat Command from 1996 – 1999. Previously, he served as the Commander in Chief of the U.S. Air Forces in Europe and the Commander of the Allied Air Forces in central Europe from 1995 – 1996.

Admiral Ronald J. Hays, USN (Ret.)

Admiral Ronald J. Hays served as the Commander in Chief of the U.S. Pacific Command until his retirement. He was selected as Commander in Chief, U.S. Naval Forces Europe in 1980 and served as the Vice Chief of Naval Operations from 1983-1985.

General Richard D. Hearney, USMC (Ret.)

General Richard D. Hearney served as Assistant Commandant of the Marine Corps from 1994 – 1996. His staff tours included Deputy Director, J-3 at the U.S. European Command as well as the Deputy Chiefs of Staff for Requirements and Programs, and Aviation at Headquarters Marine Corps in Washington, D.C.

BIOGRAPHIES

General James T. Hill, USA (Ret.)

General James T. Hill commanded the United States Southern Command from 2002 until his retirement in 2004. He previously served as Commanding General, 25th Infantry Division (Light) beginning in June 1997, a position he held until he was named Commanding General, I Corps and Fort Lewis, in September 1999. He was also a Base Realignment and Closure Commissioner for 2005, a Presidential Appointment.

Admiral James R. Hogg, USN (Ret.)

Admiral James R. Hogg served as the U.S. Military Representative to the NATO Military Committee from 1988 – 1991. Previously, he served as Commander of the United States Seventh Fleet. A graduate of the U.S. Naval Academy, he served for 35 years before his retirement. He is currently the Director of the Chief of Naval Operations' Strategic Studies Group.

General James L. Jamerson, USAF (Ret.)

General James L. Jamerson served as the Deputy Commander in Chief of the U.S. European Command from 1995 until his retirement in 1998. Previously, he served as the Commander, U.S. Air Forces in Europe and as the Commander of Allied Air Forces Central Europe.

Admiral Gregory G. Johnson, USN (Ret.)

Admiral Johnson assumed duties as Commander, U.S. Naval Forces Europe and Commander in Chief, Allied Forces Southern Europe in 2001. His prior assignment was as Commander, United States Sixth Fleet and Naval Striking and Support Forces Southern Europe. Previously, he served as the Senior Military Assistant to the Secretary of Defense. He retired in December, 2004.

Admiral Jerome L. Johnson, USN (Ret.)

Admiral Jerry Johnson served as the Vice Chief of Naval Operations before retiring in 1992. He was the longest-serving active duty naval aviator. Previously, Admiral Johnson served as the Director for Strategy, Plans, and Policy, and of General Planning Programming; and Director of Program Appraisal for the Secretary of the Navy.

General James L. Jones, USMC (Ret.)

General James L. Jones served as the Supreme Allied Commander, Europe and Commander of the United States European Command until December 2006. From 1999 to 2003, he was the 32nd Commandant of the Marine Corps. General Jones retired from active duty in the U.S. Marine Corps on February 1, 2007, after more than 40 years of service.

General John P. Jumper, USAF (Ret.)

General John P. Jumper served as Chief of Staff for the Air Force from 2001 – 2005. Previously, he was the Commander of the Air Combat Command. He also served as the Commander in Chief of the U.S. Air Forces in Europe, Commander of the Allied Air Forces in Central Europe and the Senior Military Assistant for Secretary of Defense Dick Cheney and Les Aspin.

General Paul J. Kern, USA (Ret.)

General Paul J. Kern retired from his position as the Commanding General, Army Materiel Command in 2004. Previously he was the Senior Advisor for Army Research, Development and Acquisition until 2001. General Kern also commanded the 4th Infantry Division.

General William F. "Buck" Kernan, USA (Ret.)

General William F. "Buck" Kernan served as the Commander in Chief of the United States Joint Forces Command and Supreme Allied Commander of the Atlantic. General Kernan commanded the 101st Airborne Division from 1996 until 1998 and assumed command of the XVIII Airborne Corps in March 1998.

BIOGRAPHIES

Vice Admiral Stephen F. Loftus, USN (Ret.)

Vice Admiral Loftus culminated a thirty-five year career in the United States Navy as the Deputy Chief of Naval Operations for Logistics. Admiral Loftus also served as Director of the Department of the Navy's Office of the Budget, and later as the senior uniformed advisor on the personal staff of the Secretary of the Navy.

General John Michael Loh, USAF (Ret.)

General John M. Loh served as Commander of the Air Combat Command until his retirement in 1995. Previously, he served as Commander of the Tactical Air Command. General Loh was the Vice Chief of Staff for the U.S. Air Force before assuming command of the Tactical Air Command.

Admiral T. Joseph "Joe" Lopez, USN (Ret.)

Admiral Joe Lopez served as the Commander in Chief of the U.S. Naval Forces in Europe and as the Commander in Chief of the Allied Forces Southern Europe from 1996-1998. In 1996 he commanded the NATO implementation Forces (IFOR) in Bosnia. Admiral Lopez commanded the United State's Sixth Fleet in 1992-1994.

Admiral James M. Loy, USCG (Ret.)

Admiral James M. Loy was the Deputy Secretary of the Department of Homeland Security from 2003-2005 and the Administrator of the Transportation Security Administration from 2002-2003. He retired from the Coast Guard as its Commandant on May 30, 2002. Prior to his service as Commandant, Admiral Loy served as the Coast Guard Chief of Staff from 1996 – 1998. From 1994 – 1996 he was Commander of the Coast Guard's Atlantic Area.

Lt. General Paul T. Mikolashek, USA (Ret.)

Lt. General Paul T. Mikolashek served as the Coalition Forces Land Component Commander and Commanding General of the Third Army during operations in Afghanistan from 2000 – 2002; and the Commanding General of the Southern European Task Force (Airborne) from 1998 – 2000. His final assignment was The Inspector General, U.S. Army.

Admiral Robert J. Natter, USN (Ret.)

Prior to his retirement in 2003, Admiral Robert J. Natter served as the Commander, U.S. Atlantic Fleet/Fleet Forces Command. A distinguished graduate of the U.S. Naval War College, his service included ship commands and a Naval Special Warfare Detachment in Vietnam. He also commanded the U.S. Seventh Fleet in Asia.

Lt. General Gregory S. Newbold, USMC (Ret.)

At the time of his retirement, Lt. General Gregory S. Newbold served as the Director for Operations, The Joint Staff. Lt. General Newbold commanded the 15th Marine Expeditionary Unit, which was in the vanguard of the U.S. commitment for Operation RESTORE HOPE in Somalia. He also served as Commanding General, First Marine Division.

Admiral Donald L. Pilling, USN (Ret.)

Admiral Donald L. Pilling served as the Vice Chief of Naval Operations from 1997 until his retirement in 2000. Previously, he served as Deputy Chief of Naval Operations, Resources, Warfare Requirements and Assessments. Before this, he was the Director for Programming on the staff of the Chief of Naval Operations.

Admiral Joseph W. Prueher, USN (Ret.)

Admiral Joseph W. Prueher served as Ambassador to the People's Republic of China from 1999 to 2001. He was the United States Navy Admiral and Commander in Chief of the U.S. Pacific Command from 1996 – 1999 and Vice Chief of Naval Operations from 1995 – 1996. Previously, Admiral Prueher served as Commandant of Midshipmen of the U.S. Naval Academy, Commander of Carrier Battle Group One based in San Diego and Commander of the U.S. Sixth Fleet and NATO Striking Forces.

Lt. General Harry D. Raduege, Jr., USAF (Ret.)

Before his retirement in 2005, Lt. General Harry D. Raduege, Jr. served as Director of the Defense Information Systems Agency; Commander of the Joint Task Force, Global Network Operations and the Deputy Commander for Global Network Operations and Defense for U.S. Strategic Command Joint Forces Headquarters, Information Operations. Previously, he served as Manager of the National Communications System.

Vice Admiral Norman W. Ray, USN (Ret.)

Vice Admiral Normam W. Ray served as the Deputy Chairman of the NATO Military Committee from 1992 until his retirement in 1995. Previously, Admiral Ray served as the NATO Assistant Secretary General for Defense Support.

General Robert W. RisCassi, USA (Ret.)

General Robert W. RisCassi served as Commander in Chief of the United Nations Command, as well as the Commander in Chief of the Republic of Korea/U.S. Combined Forces Command from 1992 – 1993. Previously, he served as Commanding General to the Eighth United States Army and as Vice Chief of Staff of the United States Army.

General Peter J. Schoomaker, USA (Ret.)

After a short retirement, General Peter J. Schoomaker returned to active duty and became Chief of Staff of the United States Army in 2003. He previously served as the Commander in Chief, U.S. Special Operations Command from 1997 – 2000. In 1996, he commanded the United States Army Special Operations Command at Fort Bragg.

General Henry H. Shelton, USA (Ret.)

General Henry H. Shelton served as Chairman of the Joint Chiefs of Staff from 1997 – 2001. Before serving as Chair of the Joint Chiefs, he held the position of Commander in Chief for the U.S. Special Operations Command from 1996 – 1997. General Shelton led the Joint Task Force responsible for Operation Uphold Democracy in Haiti in 1994. He retired from the Army in 2001. He has been awarded the Congressional Gold Medal and Knighted by Queen Elizabeth II.

General Eric K. Shinseki, USA (Ret.)

General Eric Shinseki served as the 34th Chief of Staff, United States Army. Prior to that, he served as Army Vice Chief of Staff (1998-1999). His last operational assignment, prior to returning to Washington, was to serve simultaneously as Commander, U.S. Army, Europe; Commander, Allied Land Forces, Central Europe; and Commander, Peace Stabilization Force, Bosnia-Herzegovina (1997-1998).

Admiral Leighton W. Smith, Jr., USN (Ret.) - Co-Chair, National Security Advisory Council

Leighton W. Smith, Jr. is a retired four-star admiral in the United States Navy. In 1994, he became the Commander in Chief of U.S. Naval Forces Europe and Allied Forces Southern Europe. The following year, he took on command of the NATO-led Implementation Force (IFOR) in Bosnia. He held all three positions until his retirement in 1996.

Admiral William D. Smith, USN (Ret.)

Before his retirement in 1993, Admiral William D. Smith served as the United States Military Representative to the NATO Military Committee in Brussels, Belgium.

General Carl W. Stiner, USA (Ret.)

General Carl W. Stiner served as the Commander in Chief of the United States Special Operations Command until his retirement in 1993. Previously, as the Commanding General of the XVIII Airborne Corps, he was designated Commander of the Joint Task Force South and served as the operational commander of all forces employed on Operation Just Cause in Panama in December 1989.

General Gordon R. Sullivan, USA (Ret.)

General Gordon R. Sullivan culminated his service in uniform as the 32nd Chief of Staff of the Army and as a member of the Joint Chiefs. During a distinguished Army career, General Sullivan also served as Vice Chief of Staff and as the Deputy Chief of Staff for Operations and Plans.

Admiral Carlisle A. Trost, USN (Ret.)

At the time of his retirement in 1990, Admiral Carlisle A. Trost served as the Chief of Naval Operations. He previously served as the Commander in Chief of the U.S. Atlantic Fleet and the Deputy Commander in Chief of the U.S. Atlantic Command.

General Charles F. "Chuck" Wald, USAF (Ret.)

General Charles F. "Chuck" Wald was the Deputy Commander of United States European Command from 2002 – 2006. General Wald commanded the 31st Fighter Wing at Aviano Air Base, Italy and the 9th Air Force and U.S. Central Command Air Forces. Prior to assuming the Deputy Commander position, he was Deputy Chief of Staff for Air and Space Operations at the Pentagon.

General Charles E. Wilhelm, USMC (Ret.)

General Charles E. Wilhelm served as Commander of the U.S. Southern Command from 1997 until his retirement from the Marine Corps in 2000. Following two combat tours of duty in Vietnam, he later served as Commanding General of the 1st Marine Division and as a Deputy Assistant Secretary of Defense.
